## **Season Changes**

Due to lack of volunteers, certain season changes will be implemented.

- 1) there will be no games during the week days
- 2) Games will be held only on Saturdays
- 3) There will not be a final playoff day
- 4) Formation of teams
  - a. Each team will be required to have a parent, guardian or family friend step up to fulfill the below positions, if these positions are not filled, a refund for the entire team will be giving during the coach/parent meeting.
    - i. Coach
    - ii. Assistant Coach
    - iii. Two certified referees (U6 division is excluded from this requirement)
      1. must attend the certify class
      2. Must referee a later to be determined upon division number of teams' amount of games. If specified amount of games is not fulfilled, team will not be eligible for playoff trophies.
    - iv. Team parent
- 5) Will attempt to implement with Region 166 (Sparks AYSO) to get the U12 division into the Inter-Regional Sportsmanship Tournament.
- 6) This season the region will be accepting mail-in registrations for early registration with a post marked cut off date.
- 7) The region will attempt to establish Rankings on all players to better balance teams. These ranking must be completed prior to the May 26<sup>th</sup> drop team date. May have to move calendar around to accommodate the Ranking system.
- 8) Hyundai is no longer a national sponsor; therefore, we will no longer be receiving the coach's kits. Will look into cost of providing coaches kits through the region.

- 9) As it stands, the region will be having a picture day, but no Soccerfest, due to that position not being filled. It has been set as an option on the calendar if someone does step forward to volunteer.
- 10) The region will once again have a mandatory meeting for all parents and coaches. These meetings have been changed so that each division will meet separately. Teams will receive their equipment at this point, but not their uniforms. Uniforms will be distributed on “Opening Day”, July 28<sup>th</sup>, at which time we plan on distributing the candy for the fundraiser.

### **Sections Meeting**

Sections will be held in Reno at the Grand Sierra Resort this year from March 23<sup>rd</sup> through March 25<sup>th</sup>. The region has acquired a suite room that all attending the meetings may utilize throughout the day.
