Fundraiser

Alternative Shane Moore ARC

Currently the region has implemented for the first time a "Team Sponsorship" fundraiser. The league has given the teams a choice between the "team sponsorship" or an alternative fundraiser, for example: candy bars or popcorn are the two items on the table. The alternative fundraiser will need to be discussed further, since currently we have no way to handle the distribution of candy bars during an extremely hot month.
